 - d. In whose name the building / land is registered.
 - e. Two photographs of the completed building taken from different angle duly certified by the architect / engineer / town planner.
 - f. Copy of the valid registration certificate of the architect /engineer /town planner, issued by the council of architecture of India / local authority/institute of town plannerIf the above documents are not submitted within eight weeks otherwise penalty will be imposed and renewal for 2017-18 will not be considered.
2. Number of teaching faculty is inadequate as per INC norms, minimum 10 (Ten) more Nursing qualified teachers should be recruited immediately to ensure 1:10 teacher student ratio, under intimation to INC within eight weeks of the receipt of this letter.
3. The institute has not submitted the compliance mentioned in the point no.2 regarding the registered list of members of Priyadrshni Rural & Tribal Upliftment Foundation as desired in our previous letter dated 01/09/2016. Hence it is further reminded to submit the same at once.

Institute name is not displayed on the INC website due to late submission of compliance. Further online application form for renewal is invited. If the institute does not submit online as on before 31stth Jan 2017 the renewal for 2017-18 will not be considered.
